



GALLEY WASTE SERVICE

(Domestic & International Biosecurity waste)

GPC is able to provide a galley waste collection service to all vessels berthed at the Port of Gladstone, Port of Bundaberg and Port of Rockhampton wharfs with fees covered in the GPC Port Charges for each Port (www.gpcl.com.au/operations/port-charges).

The service is available 12hrs a day, 7 days a week during daylight hours. Vessel Agents must contact GPC at least 24hrs prior to the scheduled collection.

The galley waste is to be separated into wet and dry, double bagged and placed into GPC provided 240L biosecurity bins for secure transport, treatment and disposal.

No further segregation / recycling of waste is possible due to the design of the treatment process to meet health, safety and biosecurity requirements.

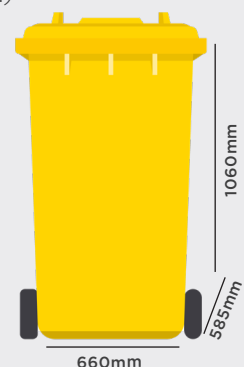
All waste is treated by a third party in accordance with an approved arrangement administered by the Department of Agriculture, Water and the Environment (DAWE).

GPC will not accept any other waste types from both domestic and international vessels.

GPC will accept galley waste from both domestic and international vessels (biosecurity) that fits into 240L wheelie bins with a particle size less than 50mm. This includes:

- food wastes
- plastic
- domestic wastes (paper, rags, glass, metal, bottles, crockery, etc.)
- animal carcasses
- fishing gear

NON -GALLEY WASTE

Vessel Agents must contact 3rd party waste providers directly for all non galley waste.

For example:

- cooking oil
- oily wastes such as oily bilge water, oily rags, oily residues (sludge), oily tanks washings (slops), scale and sludge from tank cleaning and oily mixtures containing chemicals
- chemicals
- noxious liquid substances
- sewage
- ozone depleting substances
- exhaust gas cleaning residues
- incinerator ash
- cargo residues (HME bagged dry product or wash water)
- paint tins
- dunnage
- pressurised gas container (Fire extinguishers/ gas bottles)

Refer to the International Maritime Organisation database (GISIS - <https://gisis.imo.org>) for more details, in order to meet the MARPOL international convention for the Prevention of Pollution from Ships. The Australian Maritime Safety Authority (AMSA) are responsible for keeping this database up-to-date for Australian Ports.

MARINA WASTE RECEPTION SERVICES

International yachts need to be “cleared” by the DAWE as part of Biosecurity requirements before entering the harbour / marina. The DAWE officer will remove any galley waste (garbage) on-board and provide it to GPC as biosecurity waste for treatment & disposal.

The Gladstone marina has waste oil tanks available for users of the marina which is collected by a 3rd party waste provider for recycling.
